Approval of the minutes of the Public Protection and Safety Committee meeting from May 2, 2012.

1. **Gen. Ord. No. 1-12-13 (8.1)** by Alderperson Van Akkeren, an ordinance repealing and recreating Sec. 50-697 of the Sheboygan Municipal Code so as to broaden the range of penalties for fireworks and similar violations.
2. **Gen. Ord. No. 2-12-13 (8.2)** by Alderperson Bohren, an ordinance relating to 15-minute parking limits so as to add the parking limits on the north side of Wisconsin Avenue between N. 10<sup>th</sup> Street and S. 9<sup>th</sup> Street.
3. **Gen. Ord. No. 3-12-13 (8.2)** by Alderperson Bohren, an ordinance relating to changing the speed limit on N. 15<sup>th</sup> Street between MacArthur Avenue and Grand Avenue as specified in Section 1 below:

Section 1. An ordinance to change the speed to 25 mph on N. 15<sup>th</sup> Street between MacArthur Avenue and Grand Avenue.
