A motion to approve the minutes of the previous meeting held July 15, 2014 was made by Ald. Thiel and seconded by Ald. Lessard. **All ayes; motion approved.**

R.O. No. 86-14-15 (7-21-14) - Summary of the 2015 Budget Requests for various funds

The committee will most likely hold a revocation hearing once Mr. Atilano is in violation of the cessation of business ordinance.
