- (2) **Activity Narrative:** Funds will be allocated to the development of a new skate park at Kiwanis Park. The park is located in a low to moderate income eligible census tract and will serve city residents including central city residents with an additional park amenity. The City will allocate \$200,000 towards the construction of the park to be matched with the 2016 CDBG allocation of \$231,231.
