

In accordance with regulation 24 CFR 570, the City of Sheboygan has prepared this CAPER for the periord 4/1/2019 - 3/31/2020. The CAPER presents the City's progress in carrying out projects and activities pursuant to the 2019 Annual Action Plan for CDBG funds receveid from the United States Department of the Housing and Urban Development (HUD) to principally benefit low and moderate income persons. The CAPER also provides a general assessment fo the City's progress in addressing the priorities and objectives contained in the five-year Consolidated Plan (Con Plan) 2014-2019. In 2019, the City spent approximately 100 percent of the funds on activities benefiting LMI persons.

The City also received an additional allocation in 2019 known as CDBG-CV funds. The first allocation of the CDBG-CV fund has been allocated to the following activities, Public Services, Project Administration and Microenterprises Loans. As of the writing of this report, the city has expended approximately 60 percent of the funds.

The numbers for activities with area benefit National objectives are pulled from census tract data for the neighborhood in which particular CDBG activity provides services. Sheboygan is a predominately white community, although hispanic and hmong make up almost 10 percent of our population.

The City of Sheboygan was fornuate to have a 118 unit affordable housing development underway in 2019. We also exceeded our rental assistance number for the year over year.

In 2020, the City is commissioning an a comprehensive affordable housing market study to determine the definition of affordablility for Sheboygan as well as the inventory needed for different lower incomes.

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

Outreach services are used to engage people experiencing homelessness who are otherwise unable tor unwilling to seek assistance on their own. Lakeshore CAP administers the City's Point In Time count and as part of the bi annual count, the try to understand the sitations of the homeless persons they come in contact with so, so they can be connected to the appropriate services.

Addressing the emergency shelter and transitional housing needs of homeless persons

The City of Sheboygan Continum of Care utilizes a coordinated entry system which provides a systematic process for assessing people and prioritizing them for the appropriate housing intervention based on need and vulnerability. Emergency shelter and transitional housing staff provide the valuable service of assessing program consumers and referring them to necessary services within the community.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

The City is not a recipient of the ESG and HOME funds, therefore we rely on our partners to provide services normally covered by these funds. The City supports organizations like Lakeshore CAP whom applys for rapid rehousing funds for the community.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

The City does not receive ESG funds therefore we rely on partnerships with service providers in the community.

The following are the goals and objectives for the public housing authority:

- Reduce public housing vacancies
- Continue to improve public housing management by increasing customer satisfaction
- Continue to make improvements in building components for better efficiency
- Continue working with law enforcement, background checks and building security
- Continue to take affirmative measures to ensure accessible housing to persons with disabilities
- Continue to target families below 30% of the median income level
- Continue to make structural and aesthetic improvements in tandem with the recommendations of the Green Physical Needs Assessment

The Authority recognizes that communities and families are strengthened through homeownership and the Sheboygan Housing Authority will continue to promote and provide the Section 8 homeownership program through support from partner organizations.

The City of Sheoygan has completed a comprehensive review of our ordinances and codes to make sure they do not create barriers to affordable housing. The City has one affordable multi-family project completing with 118 units, another for 200 units, a new subdivision starting soon and is completing a market study related to affordable housing.

The City completed a fair request for proposals process to allow public service agencies to submit a request for funding. The City works with applicants to make sure their programs meet the needs outlined in the consolidated plan and CAPER.

The City follows lead based paint requirements on all housing rehabilitation projects. We also partner with the Sheboygan County Health and Human Services, Public Health Division to deal with problem properties in the city that have outstanding lead related orders to correct.

The City of Sheboygan works with local public service providers and provides funding to agencies that provides service to poverty level families.

City staff works throughout the year to increase institutional structure, both within the City and throughout our partner agencies. This is accomplished through providing technical assistance on federal grant management requirements, such as growing their knowledge of Davis-Bacon requirements, financial management and other grant management procedures. Staff maintains contact with partner agencies throughout the year, offering referrals for funding and training opportunities where appropriate. All policies and procedures related to internal grant management procedures are reviewed and updated when areas of opportunity for efficiency and collaboration are identified.

Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

City staff is heavily connected to work with public and private housing and social services agencies to make the biggest impact in the local community. Evidence of this is involved in task forces, housing coalitions, and networks that connect the city to private and social service programs.

The City of Sheboygan in partnership with the Lakeshore Apartment Association held a fair housing training for local landlords. We also held the annual Landlord Training Program.

The City of Sheboygan has also worked with a developer to construction Section 42 affordable housing known as the Badger State Lofts. This project will add 118 affordable housing units to address Impediment No. 2/Recommendation No. 2 in our plan: Inadequate Affordable Housing Supply relative to resident income and Facilitate the producation of affordable and accessible housing.

The City also funded Partners for Community Development in conjunction with Recommendation No. 3, funding post-purchase counseling.

Projects and programs funded with CDBG are subject to monitoring. All recipients of CDBG public services funds are monitored regularly through monthly or quarterly reports to the city, as required by the funding agreement. Each report provides statistics on the program participants and a narrative of the activities undertaken during the reporting period. The information provided to the city is entered into the Integrated Disbursement and Information System (IDIS).

Depending on the requirements of the funding agreement, recipients of federal funding submit periodic reimbursement requests that include proof of payment of all expenses. City staff conducts annual site visits to review half of the applicants identified through a risk analysis.

The City's public comment period for the draft 2019 CAPER ran from October 4, 2020 through November 4, 2020. Notification of the availability of the draft 2019 CAPER for public comment was published in the Sheboygan Press on October 4, 2020. The draf2019 CAPER was made available for review online at www.sheboyganwi.gov and at the City Development office in City Hall. No comments were received.
