Chapter 48 - Article VII - House Numbering

Sec. 48-317 - Numbers Generally.

Under this article, the *numbers* and holders shall be uniform throughout the city. The *numbers* shall be 2½ inches by 3½ inches, *numbered* in black enamel upon either white plastic tile or white enameled vitrified tile. Such *numbers* shall be placed within 20 days after the assigning of the proper *number*. The cost of the *numbers* shall be paid by the property owner and shall be procured from the city planner. Replacement of *numbers* shall be procured from the city and paid for by the property owner.

Sec. 48-318 - Location of numbers.

Under this article, the *numbers* shall be conspicuously placed immediately above, on or at the side of the proper door of each building so that the *number* can be seen plainly from the street. Whenever any building is situated more than 50 feet from the street line, the *number* of such building shall be conspicuously displayed at the street line, near the walk, driveway or common entrance to such building and upon the gatepost, fence, tree, post or other appropriate place so as to be easily discernible from the sidewalk.
